Protien Dairy Produce Program, was created to increase both the quality and quantity of nutritious items provided to our clients every time they come in. Our clients can come in every 2 weeks. We served a total of 716 families or 1577 individuals.

Workforce Program

This program was created to serve working families, who are at work during our Tuesday and Thursday mid day distribution times. We served 59 unduplicated families consisting of 179 unduplicated individuals during this Fiscal Year. Families can come get food every 2 weeks on a Monday evening.

Diabetic and Homeless Bag Program

The diabetic bags contain 8-10 cans of low sodium soup and low-sugar items. The homeless bags contain easy to open containers of high protein food items. We handed out 763 Diabetic bags and 571 Homeless bags.
